Dear Planning Participant,

The U.S. Forest Service has developed a proposed ecological restoration project approximately four miles north of Newport within the Newport-Sullivan Lake Ranger Districts on the Colville National Forest. The Sx^wuytn – Kaniksu Connections "Trail" Project consists of portions of five large watersheds and covers approximately 90,700 acres. The project area is bordered by the Pend Oreille River on the west, the Idaho Panhandle National Forest on the east, and the southern boundary roughly follows the southern boundary of the Newport Ranger District. The north border follows the Middle Creek-Pend Oreille River watershed's north boundary.

The project has multiple purposes: to increase forest health; address risk of insect and disease outbreaks; limit uncharacteristic wildland fires; meet state and federal water quality guidelines; provide quality fish and wildlife habitat; contribute to the local economy; and connect lands and people. The proposed action was developed through coordination between the Colville National Forest, Washington Department of Natural Resources, and the Kalispel Tribe of Indians, under the Good Neighbor Authority and the Tribal Forest Protection Act. These three entities worked with each other and with interested members of the public to gather interests, concerns and ideas for management of National Forest System lands within the Trail project area. Meetings and discussions were held in various venues but primarily through six public workshops and a public field trip. The public input was combined with resource information to develop this draft Proposed Action, which is consistent with the 2019 Colville National Forest Land Management Plan.

Although information from many landowners was considered, the draft Proposed Action only includes activities on lands managed by the Colville National Forest. Maps and information about the project are available on the Colville National Forest's project webpage at https://www.fs.usda.gov/project/?project=54315, as well as on the Kalispel Tribe of Indians webpage at https://knrd.org/portfolio/sx%ca%b7uytn-trail-tribal-forest-protection-act/. Hard copies of these documents are available upon request.

We are informing you about this proposal so you can provide input to us. Your comments will be considered and used to identify issues associated with the proposal, which could lead to alternatives or mitigation measures, so please keep them as specific as possible. They will also become part of the public record. The planning process includes considering input we receive as well as conducting any necessary surveys for wildlife, sensitive plants, heritage, or other resources. We expect to have an environmental assessment available for review and a formal public comment period during the fall/winter of 2020. There will be an opportunity to comment again at that time.

Specific written comments as defined by §218.2 should be within the scope of the proposed action, have a direct relationship to the proposed action, and must include supporting reasons for



the responsible official to consider. Only those who submit timely project-specific written comments during a public comment period are eligible to file an objection.

In an effort to reduce paper use, the Newport-Sullivan Lake Ranger District encourages electronic correspondence.
